Ski Rental Agreement

Caribou Ski Programs 2023-2024



I, _____, the undersigned and hereby referred to as the renter, agree to rent _____ ski package(s) from the Caribou Parks and Recreation Department for the ski season **beginning November 16, 2023, and ending on March 26, 2024**. This Nordic ski package shall include 1 set of skis, one pair of boots, one set of poles and one equipment bag. *Skis under 137cm do not include poles or bag.

ABSOLUTELY NO EXTENSION PERMITTED

The renter agrees to a total rental fee of \$80 per package, for the season described above. (There will be an additional assessment for extra equipment and a security deposit).

If, however, it is deemed that any elements of the ski package have succumbed to excessive damage or loss of equipment has occurred, the renter agrees to reimburse Caribou Parks & Recreation Department in accordance with the fee schedule listed below.

Excessive ski base damage such as, but not limited to gouges from skiing over roads or rocks, bubbles in the base from over-heating, and other damage deemed by Caribou Parks & Recreation Department to be above and beyond normal wear from everyday use will be considered ski damage and result in a damage fee.

NOTES:

- If damage occurs, please return even partially damaged equipment immediately, pay the modest damage fee and then exchange broken equipment for replacement equipment. Do not continue to ski on partially damaged equipment, especially skis.
- Any kick waxes applied to skis must be removed prior to returning or exchanging the skis.
- Please refrain from using metal scrappers when preparing ski bottoms. Plastic scrappers only.
- **There will be a late fee of \$20 assessed on all ski equipment returned after March 26, 2024.** _____ Initial

RENTAL RELEASE AGREEMENT

No ski package may be given to a skier until the skier, or if a minor, the skier's parent, or guardian has signed the Rental Release Agreement.

1. I accept, for use by me or by my minor child, the rental equipment provided through Caribou Parks and Recreation Department and accept full responsibility for the care of the equipment while it is in my possession or the possession of my child. I have examined the equipment and accept it as is. I agree to return the equipment or pay the fees for loss or damage in the Ski Rental Agreement.
2. I understand that there are inherent and other risks involved in the sport of skiing, for which this equipment is to be used, that injuries are a common and ordinary occurrence of the sport, and I freely and voluntarily assume those risks on behalf of my child and for myself.
3. I agree to indemnify and hold harmless the City of Caribou and all agents, servants, and employees, for all claims, lawsuits, or judgments that may come because of the Caribou Ski Rental Program. This indemnification shall include but not be limited to, any settlements, judgments or awards by a court or a board of arbitration. This indemnification will also include costs for legal representation and out of pocket expenses incurred by the City of Caribou in connection with any action or defense necessary to protect itself under the terms of this agreement.

This agreement is governed by the applicable law of the State of Maine. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force effect.

I have read the Ski Rental Agreement and the Rental Release Agreement, and I voluntarily agree to the terms of this agreement.
